1. Experience of producing and supplying such material to any Govt. agencies/ corporations/ other agencies during last 5 years with proof. The total value of supplied in last one year shall be 30 lakhs or above.
2. Copy of Registration certificate of the firm/ agency with VAT/CST/export–import license etc.
3. Accreditation certificate from NATIONAL CERTIFICATION SYSTEM FOR TISSUE CULTURE RAISED PLANTS (NCS-TCP), Department of Biotechnology, Government of India for various indexing/ genetic fidelity/uniformity testing of tissue culture plant.
4. Copy of Audited Financial Statement of last three years to be submitted.

Two independent sealed envelopes should be prepared as detailed below:

Envelope 1: (Sealed):- This envelope should be marked as Technical bid and should contain papers with covering letter on letter head (with name, address etc. On left side of envelop) giving the detailed technical information. EMD amount be kept in envelop failing which financial bid will not be considered.
2. Envelope 2: (Sealed):- This envelope should be marked as financial bid and should contain offer price per unit plantlets by the party.

3. Both envelopes should be inserted in one big size envelope (sealed), superscribing tender for supply of Tissue culture Sabri Banana plantlets for implementation of project "Field demonstration of tissue culture raised Sabri Banana in Tripura State.

## Terms and condition

1. The tender shall be accompanied by interest free EMD of Rs 30000 in the form of Demand Draft drawn in favour of Member Deputy Secretary, Tripura Biotechnology Council, Agartala. EMD of the unsuccessful tenderers except the lowest three will be returned within 30 days of the tender opening. EMD of the lowest three will be returned after the entire tender process is over or within 3 months of the tender opening.
2. Should have own well established tissue culture laboratory engaged in production of tissue culture banana plants (necessary documents need to be attached).
3. The laboratory should be accredited by the Department of Biotechnology, Government of India (necessary documents need to be attached).
4. Plants should be of true to type.
5. Well hardened (should be supplied after primary hardening) healthy plants should be supplied.
6. The supplied should furnish VAT reg. number, IT return for last 3 years, trade license, P. Tax, challan and P. Tax certificate, PAN card, Audited balance sheet for last 3 years and seed license.
7. The acceptance/cancellation of the tender will depend solely on discretion of the authority and the authority is not bound to accept the lowest quotation if found unsuitable.
8. Rate quoted includes everything including transportation up to the places mentioned in the tender and tenderers will quote their rate accordingly.
9. Concerned bidders should have sufficient experience in supply of primary hardened tissue culture banana plants to various agencies and supply credential along with payment certificate needs to be furnished in this regard.
10. A supply order will be issued from the office of the undersigned after accepting the same. The tenderers must supply the item within stipulated time period as will be mentioned in the supply order, failing which his tender may be cancelled and earnest money will be forfeited. No hike of rates will be allowed later on.
- 11. Payment schedule: 60% of the total payment will made after 30 days after receipt the plantlets; 40%-60 days after of receipt of the plantlets.**
12. The rate quoted in the tender shall remain open for acceptance without any modification in rates or terms and condition of tender for a period of 6 months from the date of opening of the tender.
13. In event of any question/ dispute or difference arising between Biotechnology Council, Tripura and supplier on any matter covered by these Terms and Conditions or arising directly or indirectly there form or connected with these Terms and Conditions in any manner, the matter shall be sorted out between the TBC and supplier and in case of non-resolution of dispute the matter shall be referred to the sole arbitrator appointed by the Chairman Tripura Biotechnology(TBC) or any other competent office who at the relevant time is occupying highest office in TBC, Tripura . The tenderers shall have no objection in this regard. Also the courts of Tripura alone shall have jurisdiction to adjudicate thereon.

14. The acceptance of the tender and award of contract to one or more than one supplier if considered necessary will rest with the purchaser who does not bind himself to accept the lowest tender. The purchaser reserves the right to reject any or all the offers received, without assigning reason, whatsoever and no explanation can be demanded in case of rejection of any tender.
15. No interest will be paid on EMD.
16. Any deviation from the standard as required if found any time by the authority, the same will have to be replaced within specified time.
17. The last date for submission of the documents is 17<sup>th</sup> April, 2017 upto 5.00 p.m.
18. Before placing the supply order to the agency one expert team may visit the tissue culture and other facilities to verify the claim in the bid documents.
19. No communication shall be entertained over telephone, FAX, e-mail or in person.
20. The rate quoted should include all taxes and duties including custom duty, excise duty, service tax, sales tax, C.S.T., local taxes Trade Tax/VAT, Income Tax, Surcharge on income tax etc. if any Bidder shall be entirely responsible for all taxes, duties, license fees, etc. If any new tax/ duty are levied during the contract period the same will be borne by the firm exclusively.
21. The taxes and duties which are to be deducted at the source as per the relevant acts and rules will be borne by the TBC against which prescribed certificate will issued.
22. All the inputs required for the production including the protocol will be arranged by the bidder.
23. Pure variety of mother plants of sabri banana will be identified and marked by Tripura Biotechnology Council. The tissue culture plants obtained from the mother plants supplied by the council have to be certified by a renowned government agency for authenticity of the sabri variety. The supplier to give an undertaking along with this the bid that the authenticity certificate will be submitted during the supply of seedlings. The tissue culture plants after primary hardening developed from mother plants supplied from TBC have to be supplied within the stipulated time as per the supply order (Maximum within 6 months).
24. The Council is authorized to check randomly the authenticity of the variety and if there is any deviation in the varietal purity, the supply will be cancelled.
